I do not hold dual Domicile of another District. c. I do not have any Job in Govt / Semi Govt / Autonomous Body on the previous Domicile. d. I will face any litigation if happens, SPSC will have no legal bindings.
03	Attested Copy of present Domicile & PRC on form D with same permanent / present address of candidate as mentioned in CNIC.
04	Attested Copy of CNIC with same permanent / present address of candidate as mentioned in Domicile and PRC on Form-D.

<u>05</u>	Attested copy of CNIC with same Permanent / Present address in Domicile and PRC / Form D.
